(iv) Previous Academic Employment

In October 1979, I was appointed by the **University of Kent at Canterbury**, England, as a Research Professor. I initially joined as a **Research Associate** within the **Personal Social Services Research Unit** and the **Department of Management Sciences, Econometrics and Social Statistics**. (Note: Within the university's structure, research staff ranks—equivalent to teaching faculty—are categorized into four grades: Research Assistant, Research Associate, Research Fellow, and Senior Research Fellow). In August 1983, I was promoted to the rank of **Research Fellow**.

My responsibilities were primarily focused on research, complemented by teaching duties. My research work specialized in the development and application of statistical, econometric, and operations research models within the fields of economic and social policy. My academic contributions included delivering postgraduate-level courses in statistics, econometrics, and operations research, as well as supervising Master's and Ph.D. theses on econometric topics."

Since 1985, I have been an elected member of the Faculty of Social Sciences at the University of Kent at Canterbury. In March 1986, I was granted a two-year leave without pay and came to Greece for my military service.

Since returning to Greece, I have never stopped being active in my academic duties. I am active in both teaching and research. For several years, I taught ***Quantitative Methods*** such as ***Biostatistics*** at the **Military Medical School** and ***Statistics*** at the **Hellenic Navy**.

I have served as a referee for scientific journals. It is important to mention that the American Statistical Association uses me as a referee for articles related to the History of Statistics.

Professor **Samuel Kotz**, when including my work on Sargan distributions in the ***Encyclopedia of Statistical Sciences***, and as a referee for my work "*Univariate Sargan Distributions*," characterized my work as statistically "illuminating". My article "*The Distribution of the 2x2 Unit Normal Determinants*" is also mentioned in the ***Encyclopedia of Statistical Sciences***, my article "*Aristotle and Earthquake Data: A Historical Note*" is mentioned in the ***Encyclopedia of Earth Sciences***, and the "*Cecrops, King of Athens: The First Population Census in History*" in the ***International Encyclopedia of the Social & Behavioral Sciences***.

Professional Experience (Business)

(i) Recent Employment

Since November 2011, I have been working as a freelancer providing Management Consulting services to companies operating in Greece.

(ii) Previous Employments

Since 1979, I have provided consulting services to British entities and companies such as Civil Aviation Authority, Manpower Services Commission, Department of Education and Sciences, Department of Health and Social Security, Department of the Environment, TOYOTA Car Co., Timberlake Clark Ltd, Institute of Productivity, etc..

In July 1988, I was hired by Athens Airport S.A. as head of the company's financial studies, including organizational and operational studies. At the same time, I was also responsible for the company's IT development. I resigned in January 1990 because the company was a typical Greek public company, and no one was interested in its activities.

In February 1990, I was hired by Heinz Hellas S.A. as Director of Organization and Development. Heinz Hellas is the Greek subsidiary of the multinational Heinz. My responsibilities included the personnel department, the two canning factories, and the IT department. I also participated in all relevant European management and administrative committees of Heinz. I resigned in September 1992, and my resignation was accepted in May 1993.

From June 1993 to March 1998, I worked at Athena Finance Investment Consultancy S.A. as the Managing Director. Athena Finance, the largest independent (non-banking) financial services company until 1998, provided a wide range of financial and investment services with an emphasis on the capital market, from Portfolio Management and Asset Management, to the creation of Banks, Brokerage Companies, Capital Investment Companies, Mutual Funds, etc.

On March 18, 1998, the Greek Capital Market Commission put into effect its decision No. 123 on investment services. In April 1998, the Proti ELDE (Investment Services Firm) was created, in which, in addition to being a major shareholder, I assumed the position of its President and Managing Director. Proti ELDE is the ELDE that continuously created the quality standards of operation of ELDEs. For example, Proti ELDE is the first ELDE to be certified with ISO 9002, specifically by LLOYD'S. It is also the first ELDE to exercise the institution of sponsorship, and without advertising or fanfare. In June 2001, we transferred all of Proti's shares, and I stopped dealing with the company.

In the period 2000-2001, seeing and predicting the course of the Greek capital market, I tried to create an Investment Bank with the participation of the Agricultural Bank of Greece (49%) and professionals in the capital market (51%). Unfortunately, my efforts were not successful due to the economic situation that made 51% too expensive.

From February 2001 to November 2004, I worked as an investment consultant at Tetraktys AELDE and Oro AEPEY. In December 2004, following my own actions, Oro AEPEY was absorbed by Omega Bank.

In August 2005, Omega Bank appointed me as Managing Director of its Insurance company, Omega Insurance S.A. In January 2008, the Bank agreed to sell Omega Insurance to the ASPIS Insurance Group. Resigned in April 2008 due to disagreement with the sale of the insurance company to ASPIS Insurance Group.

From May 2008 to October 2011, I served as Chairman of the Board and Managing Director at K.P. Marinopoulos S.A., the leading pharmaceutical wholesaler in Greece. The company's core operations focused on the trade and distribution of human pharmaceuticals, over-the-counter (OTC) products, and a comprehensive range of pharmacy-related goods.

Concurrently, I held the position of Managing Director at Pharmasoft Ltd., a firm specializing in bespoke IT solutions for the pharmaceutical sector. Pharmasoft's responsibilities there included overseeing the provision of specialized software, as well as the trade and technical maintenance of pharmacy hardware systems. I concluded my tenure at both organizations in October 2011.

(iii) Other Professional Activities

Co-creator (with Ben Knox of Pfizer International and Bill Macmillan, a professor at the University of Oxford), of the computer programs QUESTAT and QED. QUESTAT is a research tool for the statistical analysis of qualitative data, and QED is a tool for managerial decision-making regarding efficiency analysis.

I have served as a member of the Board of Directors and a member of the Investment Committees of Investment Portfolio Companies (IPCs) listed on the Athens Stock Exchange. All of these participations required the approval of the Greek Capital Market Commission.

Greek media have hosted interviews, comments, and articles of mine regarding capital markets.

Founder and first President of the Association of Investment Services Companies (SEDYKA) in 1998. Resigned in 2000 to establish an investment bank, and remains Honorary President.

In 1998, on my own initiative, the Association of Securities Intermediary Services Companies (SEDYKA) was founded, the association of ELDE companies, in which I served as the first elected Chairman of the Board of Directors. I resigned in October 2000, to establish an investment bank, and since then I have been the Honorary Chairman of the Association.
